EXHIBITORS: INCOMING SHIPMENTS TO PALMS CASINO RESORT

Inbound packages/crates to Palms Casino Resort:

- All packages are sent to our Business Center office. <u>All incoming, and outgoing packages, crates, etc.</u> are subject to <u>handling fees that are charged per package and based on weight or dimensional weight, whichever is higher.</u>
- Attached are the exhibitors shipping authorization form, and the handling fee schedule. It's important to clarify that shipping costs charged by independent carriers such as FEDEX or UPS are separate from the handling fees the business center charges for both incoming and outgoing packages or crates, etc.

Business Center hours:

Monday – Friday: 10 AM – 3 PM

Saturday-Sunday: CLOSED – Hours may vary and be extended by request. Your

request must be received two weeks before your scheduled event.

Package pick up is available 24 hours a day. Outside of business hours, please reach out to the Bell Desk by dialing 6072 on any hotel phone. They will assist you with your packages for an additional fee of \$20 per cart. To avoid additional fees, please schedule delivery with the business center before the event.

OUTGOING SHIPMENTS FROM THE SHOW AT PALMS CASINO RESORT

Outbound packages/freight from <u>Palms</u> <u>Casino Resort</u>:

How to ship using your own UPS/FEDEX or private carrier account from Palms Casino Resort Hotel: (Handling fees apply based on weight or dimensional weight per item, whichever is higher).

All UPS/FEDEX labels and shipping supplies can be provided by the business center. Please call-in advance for any special package needs to keep on hand, if necessary.

Please keep in mind, FEDEX does not provide labels for ground shipments.

What If your company does not have a UPS or FEDEX account?

You can still ship through the business center via <u>FEDEX ONLY.</u>
The price of shipping is based on distance, dimensional weight, and time expected for delivery i.e. (Ground/express saver/two-day/overnight). <u>Shipping</u> <u>authorization forms must be filled out completely to process. (form below)</u>

ALL INTERNATIONAL SHIPMENTS REQUIRE A CREDIT CARD ON FILE!!! NO CHARGES TO THE MASTER FOR INTL ORDERS!!!!

- DO NOT SCHEDULE FEDEX OR UPS TO PICK UP YOUR PACKAGES!!
- Palms Casino Resort has a daily scheduled pick up from these two carriers. We will arrange for pick-up of your packages. Please contact the business center with any questions.

IF YOU SUBMIT A SHIPPING AUTHORIZATION FORM WITH CREDIT CARD INFORMATION IN ADVANCE PRIOR TO THE EVENT: Please have your packages properly labeled and ready to ship on your table at the conclusion of the event. Additionally, please leave a business card or contact information with email addresses so we can scan /email receipts for your records. The Business Center will pick up all packages directly from your



table and charge your credit card on file for the applicable handling fees, based on weight per package. You may experience shipping delays if the packages are not properly labeled or sealed or if you did not submit a shipping authorization form prior to the event.

IF YOU DID NOT SUBMIT A SHIPPING AUTHORIZATION FORM: Bring all labeled and sealed boxes to the Business Center to be shipped. A handling fee will be charged per package and based on weight or dimensional weight, whichever is higher.

FedEx and UPS shipping labels are available at the business center, and packing tape is available for purchase for \$10 a roll. The business center at Palms Casino Resort is environmentally friendly. Therefore, we offer recycled boxes to ship free of charge.

| 31.0 - 60.0 lbs. | \$15 |
| 60.1 - 150 lbs. | \$25 |

A one-time package storage fee will apply to each package received and stored for more than five (5) calendar days. Items measuring over 6.5 feet in size are considered oversize and an additional oversize fee will be assessed if stored for more than five (5) calendar days.

TERMS AND CONDITIONS

Receiving, delivery and storage charges are payable at the time of delivery. Recipients may be required to present government-issued photo identification and sign for delivery. Shippers must comply with all applicable local, state and federal laws, including those governing packing, marking, labeling and shipping.

OBTAIN APPLICABLE INSURANCE COVERAGE ON PACKAGE CONTENTS PRIOR TO SHIPPING.

Neither the Property nor FedEx Authorized Ship Center Office provide such insurance. Neither the Property nor FedEx Authorized Ship Center Office nor the employees, agents or contractors of either firm will be liable for any damages, whether direct or indirect damages, relating to or arising out of any loss or damage to any package or its contents, unless a package is lost after receipt on the Property, in which case such liability shall be limited to the lesser of \$100 or the liability of the carrier indicated above. By sending your package to the Property, you agree to be bound by any additional terms and conditions that the Property or FedEx Authorized Ship Center Office may establish from time to time for receiving and delivering packages.
